Business Arising from the Minutes

Sidewalks

Councillor Saulnier stated that he would like Council to adopt a policy via a motion and staff to create this criterion-based policy for sidewalks. The reasons for the need for this policy includes school safety. Plymouth School's evacuation policy is to cross the main road and with the amount of traffic, he would not want children crossing that busy road (traffic volume of 4000 cars a day).

CAO Muise advised that a sidewalk policy will be part of what staff will work on for 2021-2022. He advised Council that a draft policy will be ready late summer / early fall then it will be up to Council to determine when they want this policy implemented.

Warden Danny Muise advised that more investigation is needed by Council to see what is needed within a sidewalk policy, including the finances. CAO Muise advised that staff could have a policy prepared for Council in the Fall of 2021, but if Council does want sooner, they will need to determine what comes off the priority list.

It is moved by Guy Surette and seconded by Danny Muise to direct staff to investigate requirements for a sidewalk policy and present a policy to Council within the next 12 months.

Community Hall Capital Grant

Deputy Warden Albright reviewed the Memo attached to the agenda, and asked Council if they have any questions regarding who the Community Hall Grant Evaluation

committee recommended as this year's recipients. No questions were asked, and Council indicated they wanted to move forward with a motion to approve.

Letter of Support for Spiri Robotics, Inc.

CAO Muise advised Council that the Municipality of Argyle has signed a Memorandum of Understanding (MOU) with the Province of Nova Scotia, and together are working towards establishing an Aquaculture Development Area (ADA) for marine plants and shellfish. An ADA is an area that has been identified, assessed, and preapproved as a suitable and sustainable site for aquaculture. The work has been extensive, and along with many other federal, and provincial departments, as well as industry and other stakeholders, the team has been mapping the area through the collection of bathymetric data, eel grass, natural oyster beds, ghost gear, lobster grounds, navigation routes, water data, currents, rockweed cultivation, and wildlife, including bird habitats and other protected areas. They're asking for a letter of support from Council to go along with their application.

It is moved by Glen Diggdon and seconded by Danny Muise that Council provide a letter of support to Spiri Robotics, Inc.

Mariners Center Expansion and Mariners on Main Street Cost Sharing Model Council discussed the Resolution attached to the agenda, which reads:

Whereas that the Mariners Center is a regional asset providing recreational, economic, social and health benefits to the Town of Yarmouth, Municipality of the District of Yarmouth, and the Municipality of the District of Argyle (Municipal Units of Yarmouth County);

Whereas the Town and Municipality of the District of Yarmouth are currently the coowners of the Mariners Center, and that the Municipality of the District of Argyle provides annual operating funding to support the operation of the Mariners Center;

Whereas the Municipal Units of Yarmouth County recognize the need for infrastructure replacement for recreational services delivered in the County in the area of aquatics and fitness;

Whereas the Municipal Units of Yarmouth County desire a regional approach to replace aquatic and fitness centers for the benefit of the County and its residents;

Whereas the Municipal Units of Yarmouth County also desire other expanded recreational services and will consider further investments if they meet our collective budget limitations;

Whereas the Municipal units of Yarmouth County collectively agree that the Mariners Center is the ideal location for an expansion of this nature;

Whereas the Municipal units of Yarmouth County have agreed to offer aquatic, fitness and other services temporarily at the former YMCA location on Main Street until such time as the Mariners Center expansion is adequately funded;

Whereas a funding application outlining all desired Mariners Center expansion options shall be submitted to the Governments of Canada through the "Green and Inclusive Community Buildings (GICB) program" for consideration of financial support;

Whereas the Municipal Units of Yarmouth County have set an early budget, for the purposes of the GICB application, at 30 Million Dollars;

Whereas the Municipal Units of Yarmouth County shall also seek Provincial funding for this expansion;

Whereas the Municipal units of Yarmouth County are committed to funding up to 12 million dollars to cover their 30% municipal share of the Mariners Center expansion;

And Whereas the Municipality of Argyle is committed to public engagement to further inform our residents and the associated costs and benefits of the project,

Now therefore be it *resolved* that

1. The Municipality of Argyle agrees that the proportion of operational and capital funding for the Mariners Center expansion be expressed via written agreement, and shall be based on the following agreed upon cost sharing formula:

Town of Yarmouth	30.666%
Municipality of the District of Argyle	30.666%
Municipality of the District of Yarmouth	38.666%

The Municipality of Argyle agrees that the funding formula shall be updated, upon the availability of new census population data from Statistics Canada and that this revised formula would be used to share operating expenditures of the Mariners Center.

- 2. The Municipality of Argyle supports the funding application to the GICB Funding Program, and that the Mariners Center expansion is conditional on sufficient Federal and Provincial funding.
- 3. That the funding formula as expressed in item one be the same funding formula for the funding of the aquatic and fitness services temporarily located at "Mariners on Main".
- 4. That the Municipality of Argyle consider the merits of ownership of the existing and expanded Mariners Center as part of their commitment to the project.
- 5. The Municipality of Argyle agrees to undertake a comprehensive public engagement process.
- 6. The Municipality of Argyle commits to open, respectful and transparent engagement with its regional partners and stakeholders through the

implementation of the expansion project and in providing temporary services on Main Street.

7. The Municipality of Argyle is committed to a capital fund-raising and sponsorship strategy, either as lead, or as support, and in collaboration with community stakeholders engaged in this project.

Councillor Kathy Bourque advised she would like to table the motion, in order to gather more information prior to making a motion on the resolution.

Councillor Diggdon advised that he would like a social media update from the Municipality to advise the public on the current status of the Mariners Center expansion so Councillors can then take that and share on their social media platforms. CAO Muise advised that he will draft an ad, and send it to our partners for their approval, then will send to Scott Muise to upload to the Municipality of Argyle's Facebook page.

Council agreed to table this item to another Council meeting, once more information is available.

research initiative, leading to greater capacity for problem solving methodology and increased awareness. The project will therefore lead to communities' self-empowerment and recommendations to inform decision makers as they work on water literacy strategies.
