### **Presentation – Daniel Reid – Shag Harbour Incident Society**

Danny began his presentation by telling Council about his interest in UFOs. When he visited the Shag Harbour museum for the first time, he was quite disappointed in the condition of the building. The Shag Harbour Incident Society would like to elevate the event that takes place annually in this area. Danny mentioned that they have scheduled the event over 2 days this fall at the Grand Hotel in Yarmouth. They currently have 6 speakers lined up, ranging from Halifax all the way to the United States. Danny indicated that the cost of this is going to be \$12,000 just for the venue and getting the guests here. The Shag Harbour Incident Society is requesting for funding from the Municipality of Argyle. Danny mentioned that if the event doesn't take off this year, the Society cannot afford to put it on again next year. He indicated that if he can get \$10,000 from the Town and 3 Municipal Units, the Society will be able to grow this event next week. Danny also mentioned that any money that is made from this even will go towards fixing up the museum in Shag Harbour.

He stated he has brought this up to the Department of Public Works, and staff have assured him that it has been addressed and there will be lighting in the parking lot installed in the spring.

### **Councillors Report**

### West Pubnico Lift Station Pump

Acting Chief Administrative Officer, Kyle Boudreau explained to Council that one of the main 10 Horsepower pumps at the West Pubnico Lift Station on the Rock Road is no longer working. Once he started looking at a replacement, he was shocked by the price. He indicated that the budget line for the year for this plant is \$24,000 and they are currently reaching the budget line for the maintenance of this facility. Acting CAO Boudreau mentioned that this pump needs to be ordered regardless of where the funds come from, however, he is hoping Council will approve to use funds outside of the budget for this facility, as the funds currently there will need to be used for the rest of the maintenance for the year on this facility. Councillor Diggdon asked if staff received more than one quote, or if that was even possible. Acting CAO Boudreau stated that they have a current system in place for flight pumps, and there is only one supplier of flight pumps in the region. Acting CAO Boudreau wanted to mention to Council that they received a discount of approximately 25%.

It is moved by Glenn Diggdon and seconded by Richard Donaldson to approve the purchase of the pump for \$12,943.77 plus HST.

### Rocco Point Road Concerns

Warden Muise received a phone call regarding the Rocco Point Road. The resident was asking when the road was going to be fixed, as it is in horrible condition. Warden Muise indicated he thought it was on the list to be upgraded. However, there is no timeline for this to happen. He stated this resident is concerned about the condition of the road. Warden Muise is suggesting staff write a letter to the Minister of Public Works and copy our MLA, Colton LeBlanc asking to ensure that Rocco Point Road is on the list of roads that are going to be upgraded and if there is a timeline for the work getting done.
