Subject: CSAP Education Act

Hello Richard,

You may be aware that since 2018 and the publication of the Glaze Report, the CSAP has tried without success to obtain its own Education act since we are distinct in nature and the only school board in Nova Scotia. The present Education Act governs the Centres for Education such as TCRCE while we are governed by the Old Education Act of 1995-96 which is not an acceptable law. This is why we are looking for your support and that of municipal council. Our ask is that you speak of this to our provincial MLA, Colton LeBlanc, as well as any other people you know whether they be elected officials or work for the public service. It would also be very much appreciated if municipal council sent a letter to Premier Houston with copies to the Minister of Education and Early Childhood and to Colton, asking that the provincial government adopt a CSAP

Education Act in conjunction with our board.
